I understand that I may repeat a failed course only once and receive payment for the repeat. If the failure was due to absence from class I will not receive payment for the second attempt unless I receive special permission from the Financial Aid Office Certifying Official based on special circumstances related to enrollment in that course.

I understand that my benefits will be processed over a period of time by the Regional Veterans Affairs Office and that the initial processing of the paperwork required to institute my benefits generally takes several weeks to complete. I also, understand that it may take 8 – 10 weeks (or more) after the University of Mobile has submitted my enrollment certification before I will begin receiving my educational benefits.

I understand that I must report any of the following changes to the University of Mobile Veterans Services Office immediately. **Failure to do so may result in denial of future benefits and/or require repayment of benefits already received.**
